Pursuant to Article 92, Paragraph 4, and Article 93 Paragraph (4) of the Constitution of the Republic of Kosovo, based on Article 4 of Regulation No. 02/2011 on Areas of Administrative Responsibilities of the Office of the Prime Minister and Ministries, as amended and supplemented by Regulation No. 07/2011, and article 19 of the Regulation on the work of the Government of the Republic of Kosovo No. 09/2011, with the purpose of applying Law No. 02/L-37 on the Use of Languages, the Government of the Republic of Kosovo, at its meeting of 9 November 2011, brought the following:

DECISION

1. The Working Group for the Reforms of the Government Commission on Languages and for the creation of policies on the use of languages in the Republic of Kosovo is hereby established, to be chaired by the Deputy Prime Minister of Kosovo and Minister of Local Governance Administration Mr. Slobodan Petrovic.

2. The Working Groups is composed of:

- 2.1. Srdjan Popovic –Advisor to the Prime Minister –Director of Community Affairs Office -OPM;
- 2.2. Besim Kajtazi, Director of Legal Office, OPM;
- 2.3. A representative of the Consultative Committee for Communities;
- 2.4. Fehmi Stublla –Chairperson of the Language Commission;
- 2.5. Qemajl Marmullakaj – Office for Strategic Planning -OPM;
- 2.6. A representative of the Ministry of Public Administration;
- 2.7. A representative of the Ministry of Local Governance Administration;
- 2.8. A representative of the Ministry of Education, Science and Technology;
- 2.9. A representative of the Ministry for Communities and Returns.

3. The following are invited in the capacity of experts and external assistance:

- 1.1. Maurizio Montipó - Community Rights Advisor PCN (ICO);
- 1.2. Georg Eckborg –OSCE;
- 1.3. A representative of the Embassy of the United States of America in Kosovo;
- 1.4. A representative of the Swiss Embassy in Kosovo;
- 1.5. A representative of the Norwegian Embassy in Kosovo;
- 1.6. A representative of ECLO;
- 1.7. A representative of UNDP;
- 1.8. A representative of ECMI.

4. The working Group will develop and present to the Government for approval at the latest three months following its establishment, the respective legal acts and required procedures for the reformation, strengthening and increase of capacities and of the efficiency of the Languages Commission, with the purpose of increasing the efficiency of the implementation of the Law on the Use of Languages.

5. The decision comes into effect on the date it is signed.
